## CENTRAL TENDER 17-2017 FOR THE SUPPLY OF COMPUTER SCREENS FOR GOVERNMENT MINISTRIES

- 1. The Government Procurement Administration in the Accountant General Department at the Ministry of Finance (hereinafter: "the Tender Editor") is hereby publishing the tender in reference (hereinafter: "the Tender").
- 2. Within the framework of the Tender the winning bidders shall be required to supply equipment and services such as:
  - 2.1 New screens of various types and in various configurations.
  - 2.2 Trade-In of the old screens located at the client's premises.
  - 2.3 Installation of computer screens.
  - 2.4 Maintenance of the screens including keeping an inventory of spare parts.
  - 2.5 Any other equipment or service that may be required by the Tender Editor in this field.
- 3. The Tender shall be valid for twenty four (24) months from the date of the notice of the inclusion of the suppliers in the list of registered suppliers. The Tender Editor reserves the right to extend this period by a number of periods not exceeding 36 additional months (a total of up to 60 months).

- 4. The procurement period during which the winning bidders shall supply the services to the government ministries, autonomous units and auxiliary bodies that have been approved by the Tender Editor shall be determined by the Tender Editor before any competitive process, and within the framework thereof the clients shall be entitled to purchase the products and the services, including extensions and warranty and maintenance services from the winning bidder.
- 5. Preliminary conditions for participation in the Tender:
  - 5.1 The bidder is a corporation duly registered in Israel, without any debts to the Corporations Authority. It is clarified that if the bidder is a partnership, the partnership must be duly registered.
  - 5.2 The bidder complies with the provisions of the Public Bodies Transactions Law, 5736 1976, for engagement with a public body.
  - 5.3 The bidder has attached to its bid a bid bond in the sum of ninety thousand (90,000) NIS.
  - 5.4 There is no bar under any law to the bidder's participation in the Tender and, at the Tender Editor's discretion, there is no possibility of any direct or indirect conflict of interests between the affairs of the bidder or an interested party therein and the bidder's performance of the services.
  - 5.5 The bidder does not hold or is held by another bidder in the Tender (for this purpose holding holding directly or indirectly 25% or more of the means of control, within the definition thereof in the Securities Law, 5728-1968), and one party does not hold 25% or more in two bidders. Likewise, the bidder is not a sub-contractor of another bidder in the Tender, in connection with the performance of the services in this Tender. (Nevertheless, after the win the winning bidder may engage with an unsuccessful bidder for the purpose of sub-contractor services).

- 5.6 It is emphasized that for the purpose of a bidder's participation in the Tender, it must comply with all the requirements and conditions as set out in detail in the Tender documents.
- 6. The Tender is a framework tender with competitive proceedings:
  - 6.1 The first stage an examination of the bidders' compliance with the requirements of the Tender documents and the compilation of a list of registered suppliers.
  - 6.2 The second stage the performance of competitive proceedings from time to time between the suppliers in the list for the supply of the screens configurations according to the Tender Editor's requirements.

Bids in the Tender shall be submitted in sealed envelopes without any of the bidder's identification markings and they shall be marked in accordance with what is specified in the Tender documents. The envelopes shall be inserted in the Tenders Box at the Government Procurement Administration Nethanel Lorch Street No. 1, Entrance Floor, Jerusalem. The latest date for submitting bids is on May 21, 2017 at 13:00.
- 10. The Tender Editor does not undertake to select any bid whatsoever, and it shall be entitled to revoke all or part of the Tender or defer it for any reason whatsoever at its sole discretion.

11.	It is emphasized that in the event of any inconsistency between the conditions set out in detail above and what is written in the Tender documents, the Tender documents shall prevail.
