### Main Tender 18-2017 for the Supply of Computers to Government Ministries

- 1. The Government Procurement Administration in the Accountant General's Division, the Ministry of Finance (Hereinafter: 'the Tender Editor'), hereby publishes the Tender on the matter under discussion ('Hereinafter: 'the Tender').
- 2. The Tender is a framework tender with periodic competitive procedures:
  - 2.1. First stage examining the compliance of the Bidders with the requirements of the Tender documents and assembling the list of registered suppliers.
  - 2.2. Second stage execution of pricing procedures from time to time between the suppliers on the list for the supply of computer configurations according to the requirements of the Tender Editor.
- 3. The Tender will include the supply, maintenance and installation of the products listed below, and any other product or service that will be required in the field of computers: desktop computers, mini desktop computers, thin workstations, powerful workstations, all-in-one systems, industrial / hardened computers, laptops, subnotebooks, hardened laptops, tablets, hardened tablets, 2-in-1 systems.
- 4. The Tender shall be valid for twenty-four (24) months from the date of notice of inclusion of suppliers in the list of registered suppliers. The Tender Editor may extend this period by a number of periods that will not exceed thirty-six (36) additional months (total up to 60 months).
- 5. The period of purchase in which the winners will provide the services to the government ministries, the auxiliary units and auxiliary entities approved by the Tender Editor will be determined by the Tender Editor prior to each purchase. The purchasers will be entitled to purchase the products and services, including extensions and warranty and maintenance services.
- 6. Prerequisites for Participation in the Tender:
  - **6.1.** The Bidder is a corporation duly registered in Israel, with no debts to the Corporations Authority. It is hereby clarified that if the Bidder is a partnership, the partnership must be duly registered.
  - 6.2. The Bidder complies with the provisions of the Public Entities Transactions Law, 5736-1976, (Hereinafter: the Public Entities Transactions Law') Contracting with a Public Entity.
  - 6.3. There is no impediment under any law to the Bidder's participation in the Tender, and according to the Tender Editor's opinion there is no possibility of a conflict of interests, direct or indirect, between the interests of the Bidder or its interested parties and the performance of the services by the Bidder.
  - 6.4. The Bidder does not hold or is not held by another bidder in the Tender (holding for this purpose holding directly or indirectly 25% or more of the means of control, as defined in

the Securities Law, 5728-1968), and one party does not hold 25% or more in 2 bidders. In addition, the Bidder is not a subcontractor of another bidder in connection with the performance of the services in this Tender. (However, after the winning, a bidder may enter into a contract with a bidder who has not received the services subcontracting).

- 6.5. It should be emphasized that for the purpose of participating in the Tender, the Bidder must comply with all the requirements and conditions detailed in the Tender documents.

- 9. Tender proposals must be submitted in closed envelopes without any identifying marks of the Bidder and will be marked in accordance with the details of the Tender documents. The envelopes will be placed in the Tender Box at the Government Procurement Administration, 1 Netanel Lorch Street, (Ground Floor), Jerusalem. The deadline for submission of proposals is November 12, 2017 at 13:00.
- 10. The Tender Editor is not obligated to choose any bid, and he shall be entitled to cancel the Tender in whole or in part, or to reject it for any reason at his sole discretion.
- 11. It should be emphasized that in the event of a discrepancy between the conditions detailed above and those listed in the Tender documents, the Tender documents will prevail.
