Q:	The Tender Committee was requested to confirm that the wording "most recent Financial Statements shall not be earlier than 2021" refers to the Financial Statements of the last year and not the preceding two years and therefore a Participating Entity who is not a Financial Entity, does not have Financial Statements for the year 2022, at the time of the Pre-Qualification Submission Date, and that chooses to demonstrate its compliance with the Financial Pre-Qualification Requirements according to Alternative A, shall submit Financial Statements for the years 2019-2021. Q:	The Tender Committee was requested to confirm that a Participating Entity, who is not a Financial Entity, that chooses to demonstrate its compliance with the Financial Pre-Qualification Requirements according to Alternative B, shall be required to submit its most recent Financial Statements for the year 2022 (or if such Participating Entity does not have Financial Statements for the year 2022, at the time of the Pre-Qualification Submission Date, the Financial Statements for the year 2021) and is not required to submit its Financial Statements for the preceding two years.
