### **Biological Treatment of Contaminated Groundwater – Israel Military Industry at Ramat-Ha'sharon Site ("IMI") - Clarifications Notice no. 1**

Ref: Request for Information dated February 2, 2017 ("RFI")

1. Pursuant to the provisions of Section 6.4 (Clarifications) of the RFI, the Tender Committee ("TC") respectfully issues this Clarifications Notice no. 1, notifying as follows:

#### 1.1. **Postponement of Dates:**

In accordance with its authority set forth under Section 6.3 (RFI Schedule) of the RFI, the TC notifies of the following -

- (a) **Last Date for Clarifications sought by Responders** – is postponed for **April, 2 2017**.

Accordingly, Section 6.3.3 of the RFI shall be amended to read as follows:

"6.3.3 Last Date for Clarifications sought by Responders - **April, 2 2017**."

- (b) **Submission Date** – is postponed for **May 3, 2017**.

Accordingly, Section 6.3.5 of the RFI shall be amended to read as follows:

"6.3.5 **Submission Date** – **May 3, 2017**. RFI Responses shall be made to the Tender Committee's POC's email address provided in the above Section 6.2. Responders shall hold the sole responsibility to be provided with the Tender Committee's POC's confirmation that the RFI Response was adequately received."

1.2. **Section 6.3.2 – Responder’s Registration**

- (a) Please note that entities who have not completed registration by Submission Date, will be requested to provide, within their RFI Response, details relating to the Responder and a point of contact on its behalf.
  - (b) Notifications relating to the RFI Process shall be uploaded by the TC to the Websites set forth in the RFI. Notifications relating to the RFI Process shall also be sent to the email address indicated by Responders of who have registered prior to Submission Date (as provided under Section 6.4.3 of the RFI). However, it shall remain the Responder's full and sole responsibility to constantly and independently review the Websites for any notification issued by the TC. The TC shall not hold any responsibility or liability towards any entity for notifications which have not been sent to the Responder's registered email address.
2. Within the framework of a Clarification Notice to be issued separately by the TC – the TC’s responses to Requests for Clarifications that were raised, shall be provided.
3. Kindly include this Clarification Notice no. 1 to your RFI Response.
4. This Clarification Notice no. 1 – is uploaded to the Tender Committee’s Websites provided under Section 6.1 of the RFI: (a) the Government Procurement Administration’s website; and (b) the WA’s website<sup>1</sup>.
