**Exclusive distribution contract**

between

aks aktuelle krankenpflege systeme GmbH, Germany, named as aks

and

Cosmotrade Ltd. - Israel named as contract partner

**§ 1 Contract period**

The contract starts on 09.01.2012 and lasts 3 years – till 31.12.2014.

**§ 2 Contract territory**

The exclusive distribution license is given for Israel.

**§ 3 Subject matter of contract**

aks authorizes the contract partner the exclusivity to distribute the complete aks product range in Israel. This applies for all retailer shops, hospitals and other accommodations, aks will not take care of distributive actions within the country. Furthermore aks will not supply products to competitive companies within the country. The contract partner is obliged to distribute aks patient hoists with accessories, aks care beds and aks foam mattresses.

**§ 4 Size of account**

The contract partner is obliged to generate a sales volume of minimum € 110.000,- in each year with aks products. Basis are aks invoices towards contract partner. Should the contract be stopped within the midyear, sales are to be proportionally calculated for the complete calendar year. The contract should be terminated in written form 3 months before the end of the contract period. If not the contract will be prolonged for another year.

**§ 5 Technical documentation**

aks guarantees to follow all European standards for production of medical aids, named Medizin-Produkte-Gesetz (MPG), aks is obliged to upkeep the already established quality management according so ISO 9001 (manufacturer).
