NUMBER 19-2014

Tender No. 19-2014 for the hiring of vehicles of various engine capacities for self-drive in government ministries is hereby published.

1. The number of vehicle hire days per year is estimated to be approximately 200,000 hiring days.
2. The contract period for the hiring of the vehicles shall be 24 months (two years). The client reserves the option to extend the contract period for an additional two years, on identical conditions to the conditions of the original contract in general and with regard to the price in particular.
3. The client is not bound to accept the lowest offer or any offer whatsoever and it shall be entitled to cancel the tender for budgetary or other reasons. The client reserves the right to divide the performance of the work forming the subject matter of the tender among several bidders.
4. Prerequisites for participation in the tender:
 - 4.1 A valid license for self-drive vehicle hire from the Ministry of Transport, pursuant to the Supervision of Goods and Services (Tour Driving, Special Driving and Vehicle Hire) Order, 5745 – 1985.
 - 4.2 Participation in the tender is conditional upon providing all the certificates required pursuant to the Public Bodies Transactions Law, 5737 – 1977.
 - 4.3 Participation in the tender is conditional upon the deposit, together with the bid, of a bank bond (or an autonomous and unrestricted insurer's bond within the meaning thereof in the Supervision of Insurance Businesses Law, 5741 – 1981) on conditions in the sum of 500,000 NIS, to the order of the Ministry of Finance/Government Vehicle Administration, that shall be valid until October 10, 2014 ("Tender Bond"). The bond shall be linked to the Consumer Price Index known on the latest date for submitting the bids.
 - 4.4 Participation in the tender is conditional upon the purchase of the tender brochure.
5. The tender brochure may be purchased for 500 shekels per brochure, which is unreturnable. The payment shall be in favor of the Ministry of Finance – the Government Vehicle Administration (Revenue) Account Number 25458 at the Post Office Bank.

6. To obtain the tender brochure, specifying the conditions for participation in the tender, please apply to the Government Vehicle Administration offices in Jerusalem, 12 Beit HaDfus Street, Givat Shaul, Jerusalem 5th floor at Mr. Moreno Barkai's office, Sunday to Thursday from 08:00 to 15:00 (excluding festival eves, festivals and intermediate days of festivals), together with receipt confirming payment of the purchase fee.
7. Bids for the tender shall be submitted in a closed envelope without any signs identifying the bidder, in two copies, and shall note the tender number only. The envelopes should be placed in the tenders box at the Government Vehicle Administration before August 10, 2014 at 12:00.

9. In any event of a contradiction between the provisions of this notice and the provisions set out in the tenders brochure the latter shall prevail.
