TENDER 4-2014 FOR THE PURCHASE OF 600-700 CM³ MOTORBIKES

1. Tender No. 4-2014 for the purchase of 600-700 CM³ motorbikes is hereby published.
2. The term of the contract for the purchase of the vehicles shall be 36 months (three years). The client reserves the option to extend the term of the contract for an additional three years, on conditions that are identical to the original contract conditions in general, and with regard to the price in particular.
3. The client is not obliged to accept the lowest bid or any bid whatsoever and it shall be entitled to revoke the tender for budgetary or other reasons. The client reserves the right to split the performance of the work forming the subject matter of the tender among several bidders.
4. Prerequisites for participation in the tender:
 - 4.1 Participation in the tender is restricted to those on the date of submitting the bid are in possession of a valid confirmation from the Ministry of Transport that they are an authorized vehicle importer.
 - 4.2 Participation in the tender is conditional upon the provision of all the confirmations required pursuant to the Transactions with Public Bodies (Enforcement of Keeping Accounts and Payment of Tax Dues, Minimum Salary and the Legal Employment of Foreign Workers) Law, 5737 – 1977.
 - 4.3 Participation in the tender is conditional upon the deposit, together with the bid, of an autonomous and unconditional bank bond (or insurer's bond within the meaning thereof in the Control of Insurance Businesses Law, 5741-1981) of 30,000 NIS to the order of "the Government of Israel – the Ministry of Finance" valid until 1.11.2014 (hereinafter – the Tender Bond). The bond shall be linked to the Consumer Price Index known on the last day for submitting bids.
 - 4.4 Participation in the tender is conditional upon the purchase of the tender booklet.
5. The tender booklet shall be sold for 500 shekels per booklet, which is unreturnable. Payment shall be made to the order of the Ministry of Finance – the Government Procurement Administration (Revenue) Account Number 00-25636.
6. To obtain the tender booklet, which sets out in detail the conditions for participation in the tender, please apply to the Government Vehicle Administration offices in Jerusalem, 12 Beit HaDfus Street Givat Shaul for the attention of Mr. Moreno Barkai, or to the Government Vehicle Administration secretariat Sunday to Thursday from

8. Two copies of the bids in the tender should be submitted in a sealed envelope without any signs identifying the bidder, with a note of the tender number only.
