Re: Tender 78/2014 - Supply of multi-threat body armor for patrol officers

Update no. 4

Further to the tender documents published on October 6, 2014, I would like to update as follows:

1. Confidentiality and loyalty

1.1 The winner, his employees and / or his agents undertake to refrain from being in a conflict of interest or the possibility of a conflict of interest, to keep secret, do not transfer, do not inform, and not to inform any person, any information that will be transferred to them, and / or in connection with and / or pursuant and / or during the performance of the service and / or delivery of the products according to this tender, while performing the service and / or delivery of the products, prior to the commencement and / or after its execution and the course of performing the service and / or delivery of the products.

1.2 The winner undertakes to sign its employees or its agents on a "NonDisclosure Agreement", that will undertake not to transfer, not to inform, not to pass and not to inform any person - any information that will be passed on to them in connection with, or in effect, or during the implementation of the provisions of this tender, and this - during the period of execution, before the effective date, or after their execution and the course thereof below: **Appendix 12** to the attached tender.

1.3 The bidder will be required to sign a "NonDisclosure Agreement" attached as **Appendix 12** to the tender and submit it along with the bid and all other documents required to be submitted, on the deadline date.

1.4 Any violation of the security rules (including the employment of other professionals that have not been approved by the police) is a cause to stop the contact of the police with the winner immediately.

1.5 The winner, his employees or agent shall declare that they know that failure to comply with the undertaking according to the statement constitutes an offense under section 118 and section 119 of the Penal Code - 1977 (Hebrew Year ה'תשל"ז) .

2. Conflict of Interest

2.1 The bidder will list all professional relationships, business and personal connections with other factors that could create a conflict of interest with his service provided to the police in accordance with the tender proposal or even with giving in the proposal for the tender (regarding this , there is a need to specify family members or companies associated with the bidder).

2.2 The Tender Committee reserves the right to reject proposals that they think might have a conflict of interest.

2.3 The bidder will be required to sign a statement and a commitment for a "conflict of interest" attached as appendix Thirteen to the tender and submit it along with the bid and all other documents required to be submitted, on the deadline date .

3. As a reminder, the deadline date is Tuesday, January 6 .2015 at 14:00.
