REFERENCE: **PRESS RELEASE – PUBLICATION OF MINIBUSES TENDER 3-2015**

1. Tender No. 3-2015 for the acquisition of containerized commercial vehicles/small autobuses is hereby published in 5 baskets.

An estimate for the acquisition of the vehicles for the years 2015 – 2017 totals approximately 200 vehicles for Basket 1 150 vehicles for Basket 2, 45 vehicles for Basket 3, 80 vehicles for Basket 4 and 10 vehicles for Basket 5.

2. The engagement period shall be for 24 months (two years). The client reserves the option to extend the engagement period for an additional two years, on identical terms to the original engagement terms in general, and regarding the price in particular.
3. The client is not obliged to accept the cheapest bid or any bid whatsoever and it shall be entitled to cancel the tender for budgetary or other reasons. The client reserves the right to split the performance of the work forming the subject matter of the tender amongst several bidders.
4. Pre-conditions for participation in the tender:
 - 4.1 Participation in the tender is only for those who are in possession of a certificate that they are an authorized vehicle importer on behalf of the Ministry of Transport valid on the date of submitting the bid.
 - 4.2 Participation in the tender is conditional upon the provision of all the certificates required pursuant to the Public Bodies Transactions (Enforcement of Keeping of Accounts and Payment of Tax Debts, Minimum Wage and the Lawful Employment of Foreign Workers) Law, 5737 – 1977.
 - 4.3 Participation in the tender is conditional upon the deposit, together with the bid, of a bank bond (or autonomous and unlimited bond from an insurer within the meaning thereof in the Supervision of Insurance Businesses Law, 5741 – 1981) on the following terms:
 - 4.3.1 The sum of 1,250,000 ₪ for Basket 1.

- 4.3.2 The sum of 1,000,000 ₪ for Basket 2.
- 4.3.3 The sum of 250,000 ₪ for Basket 3.
- 4.3.4 The sum of 500,000 ₪ for Basket 4.
- 4.3.5 The sum of 75,000 ₪ for Basket 5.
- 4.4 Participation in the tender is conditional upon the purchase of the tender booklet.
5. The tender booklet shall be sold for 500 shekels per booklet. This sum is unreturnable. The payment shall be made to the order of the Ministry of Finance – the Government Vehicle Administration (Revenue) Account Number 0-2545-8.
6. To obtain the tender booklet, setting out the conditions for participation in the tender, please apply to the offices of the Government Vehicle Administration in Jerusalem, Beit HaDfus Street No. 12 5th c/o Mr. Moreno Barkai, or to the Government Vehicle Administration Secretariat Sunday to Thursday from 08:00 to 15:00 (excluding eves of holidays, holidays and intermediate days of holidays), together with a receipt for the payment of the purchase fees.

8. Bids in the tender shall be submitted in duplicate in a sealed envelope without any of the bidder's identifying particulars, noting only the tender number, The envelopes shall be inserted into the tenders box at the Government Vehicle Administration, **before 16.12.2015 at 12:00 pm.**
9. A non-binding study of the tender documents may be conducted at the Government Vehicle Administration website whose address is: www.mr.gov.il.
10. In any event of a contradiction between the provisions of this notice and the provisions contained in the tenders booklet, the latter shall prevail.
