REFERENCE: **PRESS RELEASE – PUBLICATION OF "SINKO" PASSENGER VEHICLE TENDER 4-2015**

1. Tender No. 4-2015 for the acquisition of passenger vehicles of various sizes is hereby published in five baskets.
 - 1.1 Basket 1 – a vehicle from licensing group 3 with a petrol/diesel engine and 4.5 doors; the official tariff price of the vehicle shall not be less than 120,001 ₪ and shall not exceed 141,000 ₪.
 - 1.2 Basket 2 – a vehicle from licensing group 3 with a petrol/diesel engine and 4.5 doors; the official tariff price of the vehicle shall not be less than 141,001 ₪ and shall not exceed 159,000 ₪.
 - 1.3 Basket 3 – a station wagon vehicle with a petrol/diesel engine; the official tariff price of the vehicle shall not be less than 120,001 ₪ and shall not exceed 141,000 ₪.
 - 1.4 Basket 4 – a vehicle with a petrol/diesel engine; the official tariff price of the vehicle shall not be less than 170,000 ₪ and shall not exceed 200,000 ₪.
 - 1.5 Basket 5 – hybrid vehicles; the official tariff price of the vehicle shall not be less than 175,001 ₪ and shall not exceed 230,000 ₪.
 - 1.6 Purchase estimate:
 - 1.6.1 Basket 1 – 500 vehicles.
 - 1.6.2 Basket 2 – 200 vehicles.
 - 1.6.3 Basket 3 – 100 vehicles.
 - 1.6.4 Basket 4 – 150 vehicles.
 - 1.6.5 Basket 5 – 15 vehicles.

2. The engagement period shall be for 24 months (two years). The client reserves the option to extend the engagement period for one year + a further year, on identical terms to the original engagement terms in general, and regarding the price in particular.
3. A separate tender for maintenance of the vehicles (hereinafter: "the Maintenance Tender") shall be published separately by "Inbal" Co.
4. The client is not obliged to accept the cheapest bid or any bid whatsoever and it shall be entitled to cancel the tender for budgetary or other reasons. The client reserves the right to split the performance of the work forming the subject matter of the tender amongst several bidders.
5. Pre-conditions for participation in the tender:
 - 5.1 Participation in the tender is only for those who are in possession of a certificate that they are an authorized vehicle importer on behalf of the Ministry of Transport valid on the date of submitting the bid.
 - 5.2 Participation in the tender is conditional upon the provision of all the certificates required pursuant to the Public Bodies Transactions (Enforcement of Keeping of Accounts and Payment of Tax Debts, Minimum Wage and the Lawful Employment of Foreign Workers) Law, 5737 – 1977.
 - 5.3 Participation in the tender is conditional upon the deposit, together with the bid, of a bank bond (or autonomous and unlimited bond from an insurer within the meaning thereof in the Supervision of Insurance Businesses Law, 5741 – 1981) on the following terms:
 - 5.3.1 The sum of 1,500,000 ₪ for Basket 1.
 - 5.3.2 The sum of 200,000 ₪ for Basket 2.
 - 5.3.3 The sum of 450,000 ₪ for Basket 3.
 - 5.3.4 The sum of 500,000 ₪ for Basket 4.
 - 5.3.5 The sum of 50,000 ₪ for Basket 5.
 - 5.4 To the order of the government Vehicle Administration / the Ministry of Finance **that shall be valid until 30.11.2016** ("the Tender Bond"). The Bond shall be linked to the Consumer Price Index known on the last date for submission of bids and in accordance with the specimen bond appearing in Appendix B of the tender.

- 5.5 Participation in the tender is conditional upon the purchase of the tender booklet.
6. The tender booklet shall be sold for 500 shekels per booklet. This sum is unreturnable. The payment shall be made to the order of the Ministry of Finance – the Government Vehicle Administration (Revenue) Account Number 0-2545-8.
 7. To obtain the tender booklet, setting out the conditions for participation in the tender, please apply to the offices of the Government Vehicle Administration in Jerusalem, Beit HaDfus Street No. 12 5th c/o Mr. Moreno Barkai, or to the Government Vehicle Administration Secretariat Sunday to Thursday from 08:00 to 15:00 (excluding eves of holidays, holidays and intermediate days of holidays), together with a receipt for the payment of the purchase fees.

 9. Bids in the tender shall be submitted in duplicate in a sealed envelope without any of the bidder's identifying particulars, noting only the tender number, The envelopes shall be inserted into the tenders box at the Government Vehicle Administration, **before 30.11.2015 at 12:00 pm.**
 10. A non-binding study of the tender documents may be conducted at the Government Vehicle Administration website whose address is: www.mr.gov.il.
 11. In any event of a contradiction between the provisions of this notice and the provisions contained in the tenders booklet, the latter shall prevail.
