**The newspaper ad wording**

**Central Tender MMM 2017-03 for Meals Clearing Services for Government Employees (Hereinafter: 'the Tender').**

1. The Government Procurement Administration in the Accountant General, the Ministry of Finance (Hereinafter: '**the Tender Editor**'), has issued a tender for the nationwide provision of meals clearing services for government employees, as well as other services, as detailed in the tender documents.
2. The tender will be held as a public tender in accordance with the provisions of Article 1 in the Mandatory Tenders Regulations, 5753 - 1993, as detailed in the tender documents.
3. The period of the contract with the winning bidder is 24 months from the signing of the agreement by the authorized signatories on behalf of the Tender Editor. The Tender Editor has the right of choice to extend this period by a number of periods not exceeding not exceeding altogether forty-eight (48) additional months (i.e. a total of 72 months) on identical terms.
4. The Tender Editor is not obligated to select any proposal, and he will be allowed to cancel the tender wholly or in part, or reject it for budgetary or organizational reasons or otherwise at its sole discretion.
5. **Prerequisites for participation in the Tender (Threshold Conditions):**
  - 7.1 The bidder is a corporation duly registered.
  - 7.2 The bidder undertakes to comply with social payments and minimum wages to its employees during the period of the contract.
  - 7.3 The bidder has a valid bookkeeping, VAT and records management certificate according to the Income Tax Ordinance and the Value Added Tax Act, 5736 - 1975, and a confirmation of the absence of convictions for offenses under the Foreign Workers Law, 5751 - 1991 and the Minimum Wage Law, 5747 - 1987.
  - 7.4 The bidder complies with stipulations 2b1(a) of the Public Bodies Transactions Law, 5736 - 1976, regarding the adequate representation of Persons with Disabilities - terms of the transaction with a public body.
  - 7.5 The bidder complies with additional conditions and other administrative requirements as specified in the tender.

7. A bidders' conference will be held at the offices of Government Procurement Administration on 28.05.2017 at 13:00. **Participation is optional.**
