**PUBLIC RFI NUMBER – 002/2015 REQUEST FOR INFORMATION –

- (c) Details regarding the method of providing the Solution.
- (d) **The possibility** of a demonstration – RFD (Request for Demonstration).

Conveying the information does not bestow upon the Informant any right vis-a-vis the Requester and does not impose any obligation whatsoever upon the Requester.
