REQUEST FOR INFORMATION (RFI) NUMBER 01-2021 ONLINE AND ELECTRONIC KYC (KNOW YOUR CUSTOMER) SYSTEMS AND SERVICES

1. BACKGROUND:

- 1.1. The Identity & Biometric Applications Unit at the National Cyber Directorate- Prime Minister's Office (hereinafter: "the Requester" or "the Unit"), is a government office established in 2011.
- 1.2. The Unit holds several responsibilities:
 - 1.2.1. To perform oversight (by law) of Israel's National E-id and E-passport project which includes a National Biometric Database (the head of the Unit also holds the role of Biometric Applications Commissioner).
 - 1.2.2. The Unit has devised Israel's National Policy for Biometric Applications, and is working with government offices to assure its implementation.
 - 1.2.3. The head of the unit serves as the advisor to the Prime Minister in the field of Biometrics.
 - 1.2.4. The Unit has devised Israel's National Policy for Secure Digital Identification, and guiding and advising the government in the field
- 1.3. In order to support its activities and to advise the rest of the government, the Unit has established a national biometric and identification laboratory, conducting tests to evaluate biometric systems, scanning devices and algorithms.
- 1.4. The Unit has international working relations with different organizations and government agencies.
- 1.5. In order to support its missions and to advise the Israeli Government, it is necessary for the Unit to acquire knowledge in the field of online and electronic KYC (know your customer) processes, by conducting surveys on KYC systems and services. This would allow the Unit to learn about their applicability in enrollment (onboarding) and authentication processes for online government services, and to assist relevant financial regulators.
- 1.6. The Unit wishes, pursuant to the provisions of Regulation 14A of the Israeli Mandatory Tenders Regulations 1993, to receive information from Israeli and international vendors and integrators, with knowledge and experience (hereinafter: "the Informants"), about products and systems in the field of KYC services applying biometric verification (mainly by mobile devices), AI algorithms, document authentication and database



analytics (hereinafter: "the Products/the Product"), that are considered to be "state of the art".

2. CONTENTS OF THE REQUEST:

The Requester is inviting the Informants to submit a reply to the Request for Information (RFI). The reply should contain some or all of the following information:

- 2.1. Methods and performance in document scanning and authentication systems, that are considered to be the most updated and advanced technologies.
- 2.2. Methods of the biometric verification of users, including face, fingerprints, voice, iris or any other modalities that are considered to be the most updated and advanced technologies.
- 2.3. Methods of detecting attempts of fraud on the biometric process, including: presentation attack detection and/or liveness and/or "deep fake" detection and/or Adversarial AI Attacks detection.
- 2.4. Test methods that are recommended to evaluate verification and validation performance (according to FATF methods).
- 2.5. Data used for identity proofing and verification (Government official database, public database, FATF Blacklists, etc.).
- 2.6. The Informants are hereby invited to send a free demonstration software/application of the KYC service or the system.
- 2.7. For this RFI, will focus on biometric recognition and document scanning for authentication. However, the Informants may supply information regarding other modules, if they find it valuable and relevant to KYC.

3. **CLARIFICATIONS**:

3.1. This Request is a preliminary request to receive information only in accordance with Regulation 14A of the Israeli Mandatory Tenders Regulations 1993, and it does not constitute a phase in an engagement of one kind or another with any of the Informants replying to the Request. It should be emphasized that the Request does not constitute any undertaking of the Requester to continue in this process, in any way whatsoever, and it does not constitute a tender and/or invitation to submit bids and/or the establishment of a vendors' list. All the expenses involved in submitting the information shall be the sole responsibility of the Informant and the Informant shall not



- be entitled to any compensation or indemnity in respect of submitting the reply to the Request.
- 3.2. The Requester does not undertake to use the information, in its entirety or partially, for the purpose of preparation of a tender, for purchasing purposes, or for any other purpose.
- 3.3. The contents of this document do not constitute any undertaking to publish a tender in the matter as aforesaid, or any undertaking vis-a-vis the details of the tender insofar as such may be published.
- 3.4. Conveying the information does not bestow upon the Informant any right vis-a-vis the Requester and does not impose any obligation whatsoever upon the Requester.
- 3.5. The Requester shall not be responsible for any payment or expense that the Informant may incur in respect of this Request and consequent upon the contacts with it, if any are held, within the context of examining the information, a demonstration or within any other context in this matter.
- 3.6. The Requester shall be entitled to use or convey to any third party, any information, or data submitted by the Informants. Including but not limited to publish by way of a tender or in any other way, specifications, characteristics or conclusions that shall be based upon the information and data that may accumulate as a result of this process.
- 3.7. If a tender is published in connection with this Request, and without any undertaking to publish one as aforesaid, a reply to this Request shall not constitute a condition for participation in the tender, shall not grant any advantage to anyone who has replied to this Request merely due to the fact that they have replied to the Request, and shall not entail their participation it the tender or engagement with them in any other way. The Requester may add terms and conditions to the tender, at the Requester's sole discretion and according to the Requester's professional needs.
- 3.8. The Requester reserves the right to ask an Informant for supplementary information and clarifications regarding the information submitted.
- 3.9. The Requester may, but is not obliged to, request that the Informant will present or sent a demonstration of the product that will be examine by a professional team on its behalf. Demonstration of the product, if it takes place, shall constitute part of the Request and shall be subject to the contents thereof. The demonstration will not be regarded as a testing and evaluation process, nor that it will be conducted upon the Product.



4. **DEMONSTRATIONS:**

- 4.1. Demonstration of the product, if it takes place, shall constitute part of the Request and shall be subject to the contents thereof.
- 4.2. The demonstration will not be regarded as a testing and evaluation process, nor that it will be conducted upon the Product.
- 4.3. There is no obligation that only Products of Informants will be evaluated.

5. PUBLICATION OF THE REQUEST FOR INFORMATION DOCUMENTS:

- 7.5. The Informant should ascertain that their questions have reached the contact person in their entirety.
- 7.6. The Requester reserves the right to conduct more than one round of clarification questions procedure.





7.7. A reply to all the clarification questions will be sent to all the Informants via Email and will be published on the websites mentioned in article 5.1.

8. METHOD OF SENDING THE REPLY:

- 8.1. The Reply to the Request for Information should be sent by electronic mail, to the contact person's e-mail address. The title of the email will be "Reply to RFI number 01-2021"
- 8.2. The Reply should be received by the Requester before the date mentioned in the Timetable in section 10 below.
- **8.3.** The Reply shall contain documents in both PDF format and WORD format, in English or Hebrew.
- 8.4. The Informant is requested to ascertain with the contact person that the Reply has been received.
