1.	<p><b>Q:</b> The Tender Committee was requested to clarify the meaning of the following sentence: "<i>most recent Financial Statements shall not be earlier than 2021</i>".</p> <p><b>A:</b> The Tender Committee clarifies that the "<i>the most recent Financial Statements</i>" is the <u>last</u> annual Financial Statements issued by the applicable Participating Entity prior to the Pre-Qualification Submission Date which may be either for the year 2022 or 2021 (solely in the event the Financial Statements for 2022 have not been issued prior to the Pre-Qualification Submission Date). In other words, in the event a Participating Entity is required to submit three (3) Financial Statements to demonstrate compliance with the Financial Pre-Qualification Requirements, it may only submit Financial Statements for the years 2020-2022 or 2019-2021, as the case may be.</p>	Invitation	Section 4
