

Participants that wish to submit their Pre-Qualification Submission on July 9, 2023, July 10, 2023, July 11, 2023 and July 12, 2023 are requested to coordinate the submission with Mr. Maor Nidam (via email: DimonaPV@inbal.co.il) at least one (1) hour in advance. Participants are advised to submit their Pre-Qualification Submission as early as possible on the dates specified in the amended Section 6.9.1 of the Invitation.

For the removal of doubt, in the event of any discrepancy between the Invitation, as previously amended, and this Addendum, the provisions of this Addendum shall prevail.
