**Invitation to Submit Proposals under Public Tender 2/24 For Replacement, Supply,  
and Installation of Building Control System  
in Hospitalization Departments at Kfar Shaul Hospital**

1. The Jerusalem Mental Health Center (hereinafter: 'the Inviter') requests proposals for replacement, supply, and installation of a building control system in hospitalization departments at Kfar Shaul Hospital.
2. The contract period is for 12 months or until project completion: whichever is earlier, as detailed in the work specifications.
3. Tender documents, including detailed participation requirements and criteria for selecting the service provider, can be viewed (and printed) on the Government Procurement Administration website at [WWW.MR.GOV.IL](http://WWW.MR.GOV.IL) (under the 'Departmental Tenders' heading).
4. Proposers may contact for additional details and/or submit clarification questions until **Wednesday, December 18, 2024 at 12:00** through the Yahalom system [מערכת יהלום](#). The Inviter will not consider information/details provided by any other party. Do not contact the Inviter through other means.
5. Only the summary appearing in the Inviter's official response document, which includes answers to clarification questions received through the Yahalom system by the required date and changes in tender conditions (if any), will be binding on the Inviter.
6. Proposals must be submitted by **Thursday, December 26, 2024 at 12:00** (hereinafter - 'the Deadline') in the digital tender box, through the Yahalom system [מערכת יהלום](#).
7. **For the avoidance of doubt, this notice contains only general and preliminary information.** The binding conditions and other details regarding the tender process and its terms are as detailed in the tender documents. It is emphasized and declared that in any case of contradiction or inconsistency between the tender documents and the above notice, the tender terms shall prevail.
8. The Inviter may, at any time before the final date for submitting tender proposals, introduce changes and corrections to the tender documents, on its own initiative or in response to participants' questions. Such changes and corrections will be an integral part of the tender conditions and will be communicated in writing to participants via email to the addresses provided by them.
9. The Inviter may, at any time until the final date for submitting proposals, advance or postpone the final submission date, by notice or letter, and change other dates and conditions related to the tender at its absolute discretion.
10. The Inviter will select the winner according to the criteria set in these tender documents. However, the Inviter may choose not to accept any proposal, and this invitation does not obligate the Inviter to execute it.
