It is hereby clarified that the participation in the Conference by a Participating Entity, its authorized representative or any other entity which is considering participating in the Pre-Qualification Process is not mandatory and shall not be considered as a Pre-Qualification Requirement. Furthermore, participation in the Conference is not subject to the payment of the Participation Fee.
5. The Tender Committee shall not be bound by, and Participating Entities shall not rely on, any oral representation or information made by the Tender Committee or participants during the Conference, and any such information shall be provided for informative purposes only.
6. Only an Addenda or written minutes issued by the Tender Committee, if issued, following the Conference in accordance with the provisions of Section 2.10.5 of the Invitation, shall be binding.
